THIRD AMENDMENT TO DECLARATION OF SUBMISSION OF PROPERTY TO HORIZONTAL PROPERTY REGIME **FOR**

PINE RIDGE, A CONDOMINIUM

5. Except for the terms and provisions of the Declaration (including all of the exhibits) which have been modified and amended by this Second Amendment to Declaration, all remaining terms and provisions of the Declaration as amended (including all exhibits) shall remain in full force and effect.




FRONT ELEVATION






LEFT ELEVATION




RIGHT ELEVATION
